What is your understanding of the Geological Disposal Facility (GDF) siting process?

- I am OK with it as long as its not very offensive on land and the main transport is via rail and not on our small roads.
- · Fairly good.
- To give information on the location of the possible siting and to get an impression of public support.
- Investigation of site suitable for safely building and maintaining a GDF.
- A preliminary investigation into suitability of location and public support.
- Somewhere to store waste.
- I have had a brief introduction.
- That you are trying to impose a GDF on an area that is unsuitable.
- That you are doing it to "create jobs" and for profit.
- It will be investigating very carefully and in conjunction with what the community would want.
- In its infancy, lots of input in community.
- Lengthy.
- · Consultative.
- Developed as going on.
- Feels (unfortunately) like a rehash of the past 20 years (whether this is fair or not Im not sure but this "issue" has gone on in this area its how it feels).
- My understanding is that a site is being looked for nationally to store nuclear waste safely in the long term. Different areas are being considered and Community Partnerships being set up to consider options.
- Allegedly subject to a local decision but who knows. However, this facility should go to the best national level site and not to the community most willing to prostitute itself.
- The Locals have to be consulted and have a referendum if they are chosen.

What do you consider to be the social, economic and environmental priorities and challenges within the Community?

- Fear of reducing house prices.
- Inequality is a significant challenge.
- Improving and expanding natural habitats would be good.
- The main challenge will be convincing people of the safety and containment of the facility along with the security for the future.
- The local communities will have some reservations with a vocal minority. These tend to misunderstand about nuclear.
- The local economy will greatly benefit as seen with other large builds such as THORP.
- Potential for significant funding into the area, future jobs, training etc.
- Low employment
- Great geographical beauty nearby needs protecting.
- Longer term surface environment considerations.
- My concern is the amount of traffic which could affect the village. There is already unnecessary traffic from Sellafield everyday.
- I am also concerned about the amount of new building, office blocks and head works.
- What will happen about the roads. How much disruption will there be in the village.
- That this should not be imposed on West Cumbria.
- Transport, employment and aging rural community.
- Keeping local technology and buildings up to date.
- Limited bus service.
- Where do I start (walk around Whitehaven and you will see what I mean). Social deprivations.
- Lack of pride in area.
- Lack of diversity in industry.
- Lack of diversity in employers/funding.
- Too many talented young people leave the area and don't return.
- It concerns me deeply that many local people are fixated on economic issues and are very pro nuclear because of Sellafield's inflated salaries. They think that nuclear waste cannot harm them because radioactivity is invisible. Environmental priorities rarely figure in their thinking until it is too late. Then they quickly complain about what they have lost.
- The wrong answers are being given to the right questions. The current view is to reinforce past failures at the expense of our common future. Copeland/Gosforth need to break with the dead technologies of the past and embrace a sustainable future.
- We would need to have any economic benefit spent very locally unlike what has happened previously.
- With more people and industrial vehicles approved there needs to be improvements to the roads as an urgent priority.
- Ensuring the disruption to adjacent communities is recognised.

- The geological finding needs to be made public. No wool must be pulled over anyone's eyes.
- Give full access to the geology reports, safety case etc.
- Local meetings where anyone can have their say and the engagement team could discuss their plans.
- Organisations such as Rotary, 41 Club, WI, UBA etc would be a good place to see people who would not normally go to one of your meetings.
- Drop in session in local villages. Talks to- local organisations eg The Rotary Club of West Lakeland, West Lakes UBA, local branches of professional societies e.g. Royal Society of ?, Institute of Thermal Engineering on the more technical aspects as well as local Parish Councils.

- Why are members of our community setting us up for a fall. The community should be prodding government to go for the best national site. They should not be selling us down the river and putting our heads on the chopping block.
- Have very local representatives as going to a single tier local government will mean there are many people in that organisation who have little interest or knowledge of the area.
- The surrounding parishes will be more effected so should the major say. The new single tier authority should have a minor involvement.
